



I understand that as a student at Calvary Murrieta Christian Schools I am called to be a disciple of Jesus Christ. This means that I am called to give a witness to my family and friends, both inside and outside of this school. God has called me as His disciple. I agree to adhere to the following Code of Conduct:

1. I will accept and act in accordance with the school's Statement of Faith, Philosophy, and Objectives, and I am committed to upholding them.
2. I agree to try at all times to manifest to other students, by daily example, the highest Christian virtue, serving as a Christian role model (1 Timothy 4:12) both in and out of school (Luke 6:40).
3. I agree that learning is not only through receiving and interpreting rational explanations of formal subject material, but even more powerfully through word, deed, example, and shared experience. I agree to bear witness to the principles I have/will learn by being a role model in judgment, dignity, respect, and Christian living. I acknowledge that this includes, but is not limited to, refraining from such activities as use of alcohol, use of tobacco and smoking products (including "vaping"), use of illicit drugs, and the use of vulgar and profane language.
4. I understand that God has a plan for me, and that sexuality is a gift from God as clearly defined in Scripture. (Romans 12:1-2; I Corinthians 6:9-20; Ephesians 4:1-11, 5:3-5; I Thessalonians 4:3-8; I Timothy 4:12; II Timothy 2:19-22; I Peter 1:15-16, 2:15-17; I John 3:1-3). I agree to conduct myself according to biblical principles at all times. This means that I will refrain from any sexual misconduct, including, but not limited to, inappropriate or unwanted touching, premarital sex, homosexual activity, sexual harassment, use or viewing of pornographic material or websites, and other forms of sexually deviant behavior. I understand that such behaviors or deviations from Scripture are grounds for expulsion.

9. I agree to follow the biblical pattern of Matthew 18:15-17 and Galatians 6:1 for conflict resolution. All differences are to be resolved by utilizing biblical principles.
